#### **HOW TO SUBMIT PUBLIC COMMENTS:**

<u>In Person:</u> Anyone who desires to address the City Council on items appearing on the agenda, <u>including Open Forum</u>, must complete and file a pink speaker's card with the City Clerk <u>prior</u> to the City Council's consideration of the item. Once the City Clerk has announced the item, no person shall be permitted to speak on the item other than those persons who have submitted their names to the City Clerk. <u>Each speaker will be allowed up to TWO (2) MINUTES to address the City Council on NON-PUBLIC HEARING items.</u>

<u>Via Zoom</u>: Anyone who desires to address the City Council on items appearing on the agenda, <u>including</u>
<u>Open Forum</u>, must raise their hand once public comment is open. <u>The public speakers attending in person</u>
<u>will be called first, followed by Zoom participants. Only those public speakers that have their hand raised</u>
<u>once the speakers are called will be recognized.</u>

<u>Via mail:</u> received by 1:00 p.m. the day of the meeting, sent to 450 Civic Center Plaza, 3rd Floor, Office of the Clerk, Richmond, CA 94804.

<u>Via eComments</u>: eComments are available once an agenda is published. Locate the meeting in "upcoming meetings" and click the comment bubble icon. Click on the item you wish to comment on. eComments can be submitted when the agenda is published and until the conclusion of public comments for the agenda item. Email your comment to <u>cityclerkdept@ci.richmond.ca.us</u> should you have difficulty submitting an eComment during a meeting.

<u>Via email:</u> to <u>cityclerkdept@ci.richmond.ca.us by 1:00 p.m.</u> the day of the meeting.

Emails <u>MUST contain in the subject line 1) public comments – Open Session prior to Closed Session; 2) public comments – Open Forum; or 3) public comments agenda item #\_\_[include the agenda item number].</u>

<u>Properly labeled public comments</u> will be considered a public record, put into the official meeting record, available after the meeting as supplemental materials, and will be posted as an attachment to the meeting minutes when the minutes are posted: <a href="http://www.ci.richmond.ca.us/Archive.aspx?AMID=31">http://www.ci.richmond.ca.us/Archive.aspx?AMID=31</a>

The City cannot guarantee that its network and/or the site will be uninterrupted. To ensure that the City Council receives your comments, you are strongly encouraged to submit your comments in writing in advance of the meeting.

<u>Procedures for Removing Items from the Consent Calendar</u>: Members of the public who request to remove an item from the consent calendar must first discuss the item with a staff member by phone or a back-and-forth email discussion, and state the name of the staff member when requesting removal of the item from the consent calendar (by 2 p.m. the day of the meeting).

Any member of the City Council who would like to remove an item from the consent calendar must notify the appropriate staff person and the City Clerk's Office prior to the meeting. Although members of the City Council are encouraged to ask questions and share concerns with staff ahead of the meeting, they are not required to do so.

The Clerk's Office must be informed of any requests to remove items from the Consent Calendar. Items removed from the Consent Calendar shall be placed at the end of the agenda for consideration.

<u>CONDUCT AT MEETINGS:</u> Richmond City Council meetings are limited public forums during which the City strives to provide an open, safe atmosphere and promote robust public debate. Members of the public, however, must comply with state law, as well as the City's laws and procedures and may not actually disrupt the orderly conduct of these meetings. The public, for example, may not shout or use amplifying devices, must submit comment cards and speak during their allotted time, may not create a physical disturbance, may not speak on matters unrelated to issues within the jurisdiction of the City Council or the agenda item at hand, and may not cause immediate threats to public safety.

Accessibility for Individuals with Disabilities: Upon request, the City will provide for written agenda materials in appropriate alternative formats, or disability-related modification or accommodation, including auxiliary aids or services and sign language interpreters, to enable individuals with disabilities to participate in and provide comments at/related to public meetings. Please submit a request, including your name, phone number and/or email address, and a description of the modification, accommodation, auxiliary aid, service

or alternative format requested at least two days before the meeting. Requests will be granted whenever possible and resolved in favor of accessibility.

Unless otherwise noted in an agenda description, all actions taken by the Council include a determination that CEQA does not apply (i.e., the action is not a project and therefore exempt from CEQA).
